If an applicant withdraws from the scheduled road test by calling (800) 256-9559 at least 72 hours prior to the scheduled road test, payment may be transferred to another road test at a later date.

**\*\*\*PRACTICING IS NEVER ALLOWED AT TEST SITES\*\*\***

Please remember to wear closed-toe shoes and bring a face mask, pen, and the following with you to your test:

Applicants UNDER the age of 18 must bring the following ORIGINAL DOCUMENTS:

1. Level I Learner's License (must be issued for at least 6 full months or 180 days)
2. Segment II Certificate of Completion (must be a printed, hard copy - cannot accept a digital copy)
3. Driving Log documenting 50 hours of supervised driving, including 10 hours at night
4. Current registration for your vehicle
5. Current certificate of insurance for your vehicle
6. A parent or legal guardian must accompany teens during their road test. No one else is permitted in the vehicle, this includes children and pets. If a parent or legal guardian cannot attend the road test, they may designate another family member that is at least 21 years old and has a current driver license to attend the road test with the applicant. For this to be allowed, the parent or legal guardian who signed for the applicant's Level One Learner's License at the Secretary of State must write a letter giving permission for the person to bring the applicant to the test. The letter must include the full names of the parent or legal guardian writing the letter, the applicant, and the person designated to accompany the applicant to the road test. The letter also must state that the applicant has completed at least 50 hours of supervised driving (including 10 hours at night), and the parent or legal guardian writing the letter must sign and date the letter.

**If any of these items are missing or are not the correct documents, the test will be terminated and result in a failure and there will not be any refunds.**

Applicants OVER the age of 18 must bring the following ORIGINAL DOCUMENTS:

1. Temporary Instruction Permit (TIP) (must be issued for at least 30 days prior to the test and/or have a valid "eligibility date") or a White Receipt/DSTAR document and home country license
2. Current registration for your vehicle
3. Current certificate of insurance for your vehicle
4. Only adult and examiner allowed in car during test, no one else is permitted. If an interpreter is needed, this must be provided by the customer, and the interpreter must have a valid identification with them.

**If any of these items are missing or are not the correct documents, the test will be terminated and result in a failure and there will not be any refunds.**

The following required equipment on the vehicle that you are using for your test, must be in working order: brakes, brake lights (including the center-mounted rear brake light on a 1986 or newer model), doors, horn, rearview mirror and outside left mirror, safety belts for all occupants, seats for all occupants, speedometer, tires (no cords showing and properly inflated), and turn signals. Safety equipment (when weather and other safety factors require) includes: headlights, lug nuts (if visible and only one missing per wheel), muffler, springs, taillights, windshield wipers and washer fluid. **NOTE:** Windshield cannot be cracked or damage.

**If the vehicle does not pass inspection, the test will be terminated and result in a failure and there will not be any refunds.**

If you bring a rental vehicle to test in, the rental vehicle contract must include the name of the customer taking the road test on their permit, and state that the vehicle is being used for the road test.

**If you must cancel your road test appointment, it must be cancelled at least seventy-two (72) hours prior to the scheduled appointment by calling (800) 256-9559, in order for the \$70 payment to be transferred to a future road test. If you do not cancel seventy-two (72) hours in advance by calling (800) 256-9559, there is a Seventy-Five Dollar (\$75.00) charge payable by credit card only. I further understand that failure to arrive on time or not showing up for my Driving Skills Test will result in a Seventy-Five Dollar (\$75.00) charge, payable by credit card only.**
